Banyan Tree Holdings Limited (the "Company") announced on 14 May 2020 that it is undertaking a renounceable and non-underwritten rights issue (the "Rights Issue") of S\$50,402,608 in aggregate principal amount of 7.5 per cent. convertible bonds (the "Convertible Bonds") convertible into new ordinary shares in the capital of the Company (the "Shares"), on the basis of 6 Convertible Bonds for every 100 existing Shares held by entitled shareholders as at the record date, fractional entitlements to be disregarded. As disclosed in the same announcement, Mr. Ho KwonPing ("Mr. Ho") has provided an irrevocable undertaking (the "Irrevocable Undertaking") to, inter alia, procure the acceptance of and payment in full for the entire pro rata provisional allotment of Convertible Bonds based on 358,948,882 Shares up to a maximum total subscription of S\$25,201,304 in aggregate principal amount of Convertible Bonds.

Pursuant to the Irrevocable Undertaking, Mr. Ho has procured HSBC (Singapore) Nominees Pte Ltd ("HSBC Nom"), acting as nominee for RHYC Pte. Ltd. ("RHYC"), to accept and pay for S\$21,670,481 nil-paid rights to subscribe for Convertible Bonds and to apply and pay for excess Convertible Bonds. Following the close of the Rights Issue, HSBC Nom, acting as nominee for RHYC, has been allotted a total of 21,670,481 Convertible Bonds.

RHYC is a company jointly owned by Mr. Ho and Ms. Chiang See Ngoh and by virtue of the Securities and Futures Act (Chapter 289 of Singapore), Mr. Ho is treated as having an interest in 21,670,481 Convertible Bonds allotted to HSBC Nom, acting as nominee for RHYC.
